ide of the passage has a small reef extending about 100 yards off the island, or perhaps less. Having hauled close round this, she anchored in 8 fathoms water, with the outer island bearing S.S.W.4 W., Rame Point E. by & S. W., and the inlet, or W., distant 2 of a mile. This bay, found etween Rame Point and the black rocks, ppeared clear, excepting off Rame Point, where heavy breakers were seen to the extent of at least 21 or 3 miles, and affords ample accommodation in its west corner from any wind to the westward of S W.; a long swell, however, even with a N.W. gale run in. Mr. F. Helpman, R.N., commanding the schooner, hoisted out his boat, and went andex amined the entrance to the inlet, which he found about 200 yards wide, but more than half with heavy rollers on it, but keeping close to the south side he found a channel of from 14 feet to 6 feet but not less, and about 20 yards wide, the entrance running nearly east and west for about 300 yards, then turned north about the same distance into a large sheet of water, whose greatest breadth was about N.E. and S.W. It was full of shoals, having no doubt passages through them. Its greatest breadth is estimated at 31 miles, and its depth about two. The next day, Mr. Helpman again went into the inlet, and passing a small island near the N.W. point found a river running, and pulling in found about 4 or 5 feet of about 30 yards wide, and running in a westerly direction ; it was beautiful tresh water at its entrance. He went about two miles up and saw it still running some considerable distance beyond, undiminished in breadth, but very much deeper having 12 feet water. He stopt at a small white sandy cliff, the land on each eide was very thickly timbered with white gum. The whole inlet abounds with wild fowl, and the river with fish.

There was no appearance of any second inlet opening into the first, but in the east corner there was the appearance of an opening like a river, which he wished to examine but unfortunately had no means of forming any but an eye sketch.

QUARTER SESSIONS-A full report of the proceedings in the Court of Quarter Sessions we are compelled to postpone, as the calender was unu-ually large, and the inquiry into the several cases occupied the time of the Court antil 8 o'clock last night. Two of the principal cases which astracted public attention we may, however, breifly advert to. The first was that of Mr. C Bussell charged with shooting a native girl 7 years of age. This gentleman pleaded guilty, but Mr. Landor, who appeared on his behalf, requested the indulgence of the Bench, to be allowed to relate the circumstances, under which the unfortunate occurrence took-place, in order that by the relation, much prejudice might be removed, and the Bench beinelined to inflict a lenient sentence. The simple facts were, that two natives came to the house of Mr. Bussel, accompanied by the girl. Previously, flour had been stolen from the adjoining mill, and the foot-steps of these natives had been sracked. When charged with the offence they denied it, but at first the girl made a partial confession, which led to a disturb ance between the whole, and the girl was removed into a separate apartment, to put a stop to this contention. Subsequently however Mr. C. Busselland Mrs. J. Bussell with her child in her arms, being present na attempt was made to extort confession of guilt, as to the flour, from this girl of 7 years of age, by snapping agun off repeatedly, at her side without a cap, this appearing not to have any effect on her mind, a cap was placed on the gun, and thinking the noise of the cap would create greater alarm, the experamental attempt was fatal, the gun being loaded, although, there was every evidence of his being perfectly unconcious of the fact. The Commissioner adadressed Mr. Bussell very forcibly on the illegality of even attempting to intimidate nan individual to produce confession. The Court had taken into consideration the circumstance of the case, and therefore fined him in one shilling, and to be discharged. The next case of general interest was that of the Crown against Mrs. Heal for perjury. arising out of an action in the Civil Court. J. Heal v. Mellersh, for breach of promise of marriage. The Jury brought in a ver diet not gui ty. Connected with this trial we take occacasion to amark, that the acting Advocate General Mr. R. Nash, for the sake of the paltry gain of a few pounds, has degraded himself, and the situation he holds. He is only for a tin e, thank God the crown adviser, and prosecu or, and here in ihis instance indesp te of all decorum, he stands

up to defend the very cause which he is bound by his position, as connected with the local government, to prosecute. We shall have a few more notes on this point shortly, Mr. acting Advocate-General will not slip out of our hands so easily as he imagines. It will be a happy day for the colony when G. F. Moore, Esq., returns to relieve us of this incubus.

There are many little details touching the indictment which are worthy of comment, but, we reserve our remarks further than to admonish the grand jury, they should take care not to find a *true bill* on the mere indictment, for Mr. Nash can be guilty of oversight. Positively, a bill was returned at this Sessions against two natives without the slightest evidence being produced. We have noticed juries in general, in this colony, and, without making any invisious distinctions from grand to petty jury, a very considerable reformation is required.

The sentences delivered were, --Robert Collins, second conviction, 12 months hard labor at Fremantle; George Blake, transportation for seven years, for forgery; J. Smith, three months hard labor; and three natives of the Vasse district, sentenced to two years imprisonment for various offences. The younger, recommended to mercy, with the understanding, that his conduct during a short period of confinement, would warrant the mitigation of the sentence.

The tenders for fre-h meat for the sup ply of the Troops, which in a great measure regulate the market price, were re ceived at the Commissariat Office last week; the lowest tender which was accepted was 72d. I his price we are informed afford an equable return to the flockmaster, and the butcher, but meat cannot be brought to market, at present, at a lower price, although the prices of stock have experienced, within the last six months, a considerable decline. A new system is about to be adopted which will be of general advantage, and will no doubt shortly tend to reduce the price of this provision without injury to either party, and the benefit of the public. We allude to the formation of homesteads in the vicinity of the towns, where sheep and cattle will be fattened, and a regular supply kept, awaiting demand, within a few miles of Perth. This arrangement so long desired, will releive the butcher from considerable expense in the transit of sheep or stock from the hill-,the stock will also be improved by being home fed.

AUSTRALIND .- The heavy gales which visit our coast at this season of the year, have made work for the gla zers at Perth, but we are informed of a circumstance, which we believe is not frequent, but peculiar, of late occurrence to the Southward. A storm arose on the night of the 17th inst. which swept the country in a most terrific manner, it was marked by the prostation of the largest trees, but was confined to a breadth of about 300 vds., other trees in the vicinity were stripped of their branches to to their forks. This passed within 400 yards of the town of Australind. The town on this beantiful site, as we are informed is progressing rapidly, but this casual circumstance will shew the necessity of building with stronger materials than those now employed; there is plenty of lime stone on the town site, we are surprised therefore to learn that the buildings are cheitly of wood. The peculiar effects of the hurricane we have noticed, is we believe of periodieal occurrence.

# To the Editor of the Porth Gazette,

I shall not desire, that if any report to our disadventage has any ground for it, you would overlook, or extenuate it : but if there be any thing advanced, without a person who can say whence he had it, or which is attested by one who forgot who sold him it, or who had it from one of so little consideration that he did not then Ithink it worth his notice, all such testimoinies as these, 1 know, you will think too flight to have any credit, against the innocence and honour of your fellow-citizen.

When an ill report is traced, it very often vanishes among such as the orator has there recited. And how despicable a creature must that be, who is in pain for what passed among so frivolous a people?
